

POSITION ANNOUNCEMENT: ASSISTANT PROFESSOR OF ENGLISH SPECIALIZING IN 20th AND 21st
CENTURY LITERATURE

The mission of the Department of English is to advance the study and teaching of literature, language, and writing. In accomplishing this mission, the Department will provide the basis for a strong liberal arts education focused on critical literacy, critical thinking, and culturally informed interpretive skills. The Department is committed to maintaining comprehensive and interdisciplinary English studies curricula for undergraduate majors and graduate students.

The Department of English at Colorado State University invites applications for an entry-level position of Assistant Professor of English specializing in 20th and 21st Century Literature. We are seeking a scholar and teacher working in any field of 20th and 21st century literature with a focus on one or more of the following areas: the environment, ecology, the anthropocene, environmental justice, bioregionalism, or animal studies. Candidates should be able to contribute both to the intellectual life of the department and to participate in and envision interdisciplinary initiatives across campus. The successful candidate will be appointed untenured and at the rank of Assistant Professor. This is a tenure-track, nine-month appointment, beginning August 16, 2017.

Required Qualifications

- PhD in English or related field of study at time of appointment
- Evidence of sustained critical and pedagogical engagement with literature in relation to the environment, ecology, the anthropocene, environmental justice, bioregionalism, or animal studies
- Evidence of potential as a teacher and a scholar

Preferred Qualifications

- Experience teaching or conducting research in interdisciplinary programs, particularly involving the sciences

Responsibilities

Duties include teaching two courses each semester made up of a mixture of introductory lower division courses, specialized upper division courses, and graduate courses for M.A. students; advising and mentoring undergraduate and graduate students; maintaining an active research agenda; and providing service to the department, university, and community. Candidates who can advance the Department's commitment to diversity and inclusion through scholarship, creative activity, teaching, and community outreach are encouraged to apply. We seek a colleague who will develop new courses, participate in University-wide interdisciplinary programs such as the School of Global Environmental Sustainability (SoGES) and Changing Climates at CSU, and eventually envision new opportunities for collaboration with students and faculty in the sciences.

Salary

Will be commensurate with assistant professor rank and experience.

General Information

Colorado State University, with an enrollment of about 30,000, is located in Fort Collins, a growing community of close to 150,000 at the base of the Rocky Mountain Front Range, 65 miles north of Denver. Master of Arts degrees are offered in creative nonfiction, English education, literature, rhetoric and composition, and TEFL/TESL. The Master of Fine Arts program offers degrees in fiction and poetry. The CSU English department is also home to the Center for Literary Publishing and the *Colorado Review*.
